Wage and Fringe Benefits: Pay starts at \$16.50 per hour for the Residential Wireman program or \$21.36 per hour for the Inside Wireman program, with periodic advancement, as per IBEW/NECA Collective Bargaining Agreements (as of 6/01/2019). Medical and Retirement benefits are provided as per the respective program's Collective Bargaining Agreement, based on hours worked.

Characteristics of the Trade: The apprentice will work under the supervision of a State of California Certified Journeyman Electrician. The trade requires physical and mental effort on the part of the apprentice including, but not limited to: climbing, crawling, crouching, lifting, using motorized and hand tools, electronic test equipment, and working in cramped quarters. Mechanical ability and finger dexterity are essential. Work may be performed indoors or outdoors, in new and old construction environments.

Program Scope- Inside Wireman: The Inside Wireman Electrical Apprenticeship is a five-year training program that consists of 8,000 hours of paid on-the-job training, in addition to 900 hours of classroom instruction over 5 years. Classes are held four separate weeks per academic school year at our Electrical Training Center in Santa Rosa. Apprentices are paid while they work, with wages starting at 40% percent of Inside Journeyman Wireman wage with an increase of 5% every six months, or every 1,000 hours worked, and satisfactory completion of the appropriate school year.

Program Scope- Residential Wireman: The Residential Wireman Electrical Apprenticeship is a 3-year training program that consists of 4,800 hours of paid on-the-job training, in addition to 480 hours of classroom instruction over 3 years. Classes are held two nights per week at our Electrical Training Center in Santa Rosa. Apprentices are paid while they work. Current starting pay is 50% of Residential Journeyman rate with increases every 800 hours worked and satisfactory completion of the appropriate school year.

Individuals who can show that they meet the conditions listed below, after making a qualified application, will be afforded an oral interview by the JATC. Once interviewed, an applicant shall remain active on the eligible Applicant List, subject to selection, for a period of two (2) calendar years from the date of interview.

APPLICANTS MUST MEET THE FOLLOWING REQUIREMENTS:

- Be 17 ½ years old to apply and 18 years or older to enter apprenticeship. Valid photo I.D. required. (If selected for apprenticeship, you must have a valid Driver's License at the time of registration.)
- You must complete an application form, accurately responding to all questions, including but not limited to, statements indicating you are:
 - Able to safely perform the essential work of the trade.
 - Able to get to and from jobsites, as assigned.
 - Able and willing to attend all Related Supplemental Instruction, as required.
 - Able to read, hear, and understand instruction and warnings.
 - Show evidence of successful completion of: (1) One full year (2 semesters) of High School algebra with a minimum grade of "C" or equivalent; (2) One semester of college Algebra with a "C" or better; or (3) Provide evidence of successful completion of the Electrical Training Alliance Tech Math Course (available online at www.electricaltrainingalliance.org). Pre-Algebra does not meet this requirement.
- Must be at least a high school graduate, or have a G.E.D., or have a 2-year Associate Degree or higher.
- Must provide official sealed transcripts for High School and/or post high school education or training. G.E.D. records must be submitted if applicable. All records and transcripts must be in English.
- Must score a minimum of "4" for the Residential or "5" for the Inside Program, on the Electrical Trades Aptitude Test developed and validated by the American Institutes for Research. The aptitude test includes reading comprehension and basic algebra.
- Pre-employment drug testing will be required before an applicant is accepted into the apprenticeship program.
- You must submit a complete application. All required documentation must be provided by the applicant in order to complete a "qualified" application.
